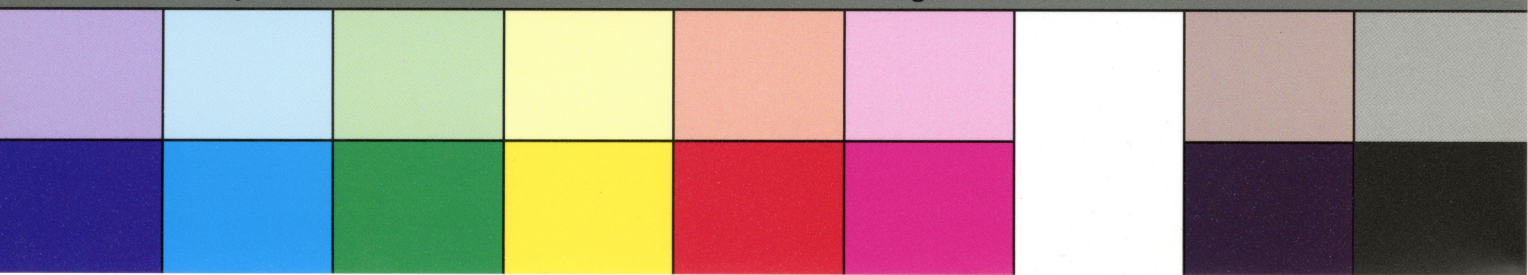
State Tax on Premiums Collected 1 per cent.
