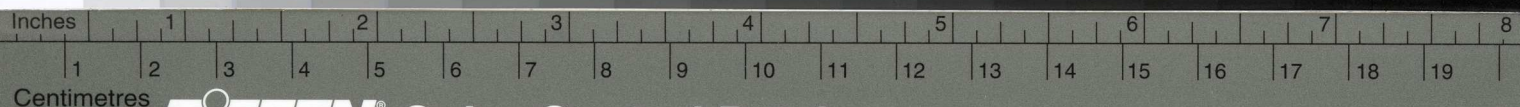
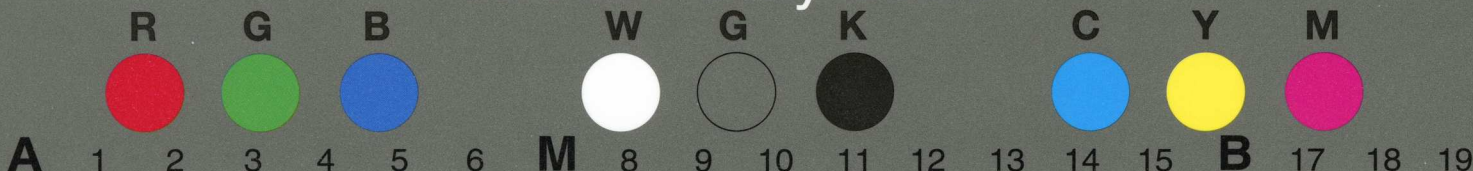


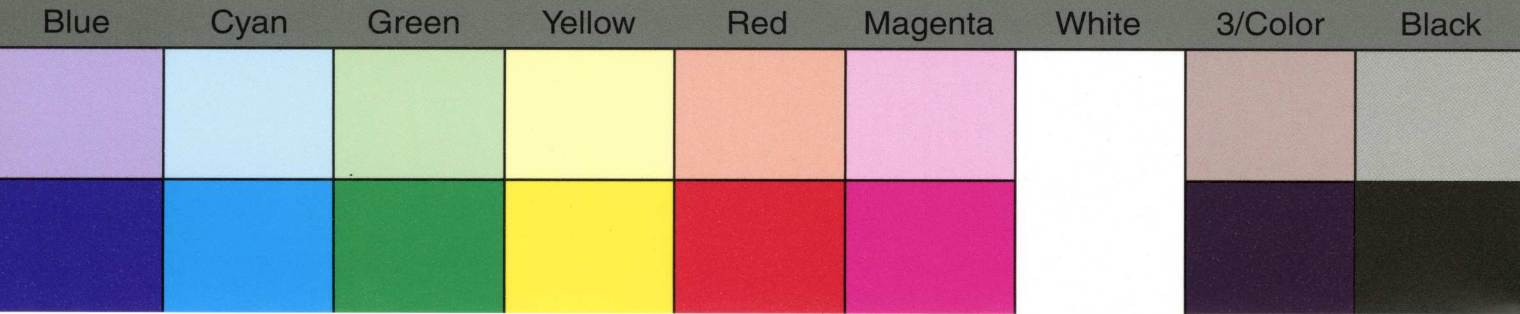
# TIFFEN® Gray Scale

Extract from Ordinance of Councils, Approved Dec. 31st, 1877:—That up n all taxes paid on or before the thirty-first of August, a discount at the rate of four per cent. per annum shall be allowed. If paid after the thirty-first day of August, and on or before the fifteen'h day of September, an addition or penalty of one-half of one per cent. shall be added and made payable to the same. If paid after the fifteenth day of September, and on or before the first day of October, there shall be an addition or penalty of one per cent. If paid after the first day of October, and on or before the fifteenth day of October, there shall be an addition or penalty of one and one-half per cent. If paid after the fifteenth day of October, and on or before the first day of November, there shall be an addition or penalty of two per cent. If paid after the first day of November, and on or before the fifteenth day of November, there shall be an addition or penalty of two and one-half per cent. If paid after the fifteenth day of November, and on or before the first day of December, there shall be an addition or penalty of three per cent. If paid after the first day of December, and on or before the fifteenth day of December, there shall be an addition or penalty of three and one-half per cent. If paid after the fifteenth day of December, and on or before the first day of January, there shall be an addition or penalty of four per cent added to and made payable upon the same.
