On the first day of July 1867 The Confederate States of America will pay to the Bearer of this Bond at the Seat of Government or such place of Deposit as may be appointed by the Secretary of the Treasury the sum of **One Thousand Dollars** with interest thereon from this date payable at the same places semi-annually at the rate of Eight per cent per annum on six months of the annexed Warrants or Coupons. This debt is authorized by an act of Congress approved August 19 1861 entitled "An Act to Authorize the issue of Treasury Notes and to provide a War tax for their redemption."

In Witness Whereof the Register of the Treasury in pursuance of the said Act of Congress hath hereunto set his hand and affixed the seal of the Treasury at Richmond this 22 day of Jan'y 1862
