Trial of the Eclipse Steam Fire Engine.—Yestrday afternoon, the Cincinnati steam fire engine Eclipse was tried in Arch street, above Eleventh. The trial was superintended by Mr. A. B. Latta, the builder. There were not many lookers on, no public notice baving been given of the trial. Steam was raised in ten minutes. After raising steam, the Eclipse played first through 200 feet of hose and an inch and an eighth nozzle, 258 feet, receiving her supply of water from one plug. With an inch and a quarter nozz'e, she threw a stream 225 feet, through the same length of hose as before. She then played two streams at once, which was not measured, but the distance appeared to be about 140 feet. Her performance yesterday was rather better than on Monday last, but if does not appear from either trial that she is superior to the steamengines built in this city. The Philadelphia steamer, at the late trial on Boston Common, threw water 255 feet, the same distance as the Eclipse did yesterday, although she is smaller and not as pow erful. The engine was returned to the house of the Diffent Engine Company. She will be taken to New York to-day.

What the Paupers Cost.—A special meeting of the Board of Guardians of the Poor was held, on Friday afternoon, for the purpose of considering the annual appropriation bill for 1859, which will be presented to City Councils for their action. The sum total demanded for the support of the family of paupers saddled upon the city amounts to the snug sum of \$260,195. The heaviest item is \$30,500 for heef, mutton and pork; then comes \$26,800 for flour and corn meal. Coal for the use of the Almshouse sums up \$10,800; tea and coffee \$7,000; brown sugar \$5,200; butter and lard \$2,800; molasses \$3,100; potatoes and beans, \$3,100; marketing, \$4,000; drugs and medicines, \$6,500; brandy for the Hospital, \$250; wines, \$650; whiskey, \$700; porter, \$1,300; tobacco, \$1,700; wood for fuel, \$1,700. The bill was ordered to be printed for the use of the members.
