

AND IT IS FURTHER ENACTED, That upon Approbation of the Directors, and Payment of the said Money, the Party paying it, shall receive of the Treasurer a Certificate under his Hand and the Seal of the Company, containing the Name of the Person and the Sum paid, the Time when and the Account or Use for which he paid it: Of all which a Record shall be made in the Records of the said Company. Which Certificate shall entitle the Person therein mentioned, to a Share in the Company Books, Estate and Effects, and to be deemed a Member.

IT IS ENACTED, for the Preservation of a just Equality among the Members of the Library Company, That no Person being a Member and holding a Share in the Library, &c. shall Grant, Sell or Convey to any other Member, or accept of a Grant, Bargain, Sale, or other Conveyance or Assurance from any other Member of any Share or Shares in the Books, Estate and
